#### F. GENERAL ADMINISTRATION

### 1. Sublimit for Injunctive Relief Defense Costs

Mr. Matt Gowan said injunctive relief is not an insurable risk, but some JPAs provide a sublimit and last year this JPA added a sublimit for injunctive relief defense costs. The sublimit is \$100,000 and no aggregate limit was included. At that time, based on the JPA's history, injunctive relief claims were rare; approximately one every five to ten years. Now within the last year, the JPA has received two injunctive relief claims. Mr. Gowan recommended reviewing this again and perhaps adding an aggregate limit. After discussion, the Executive Committee decided the injunctive relief defense costs sublimit should be \$50,000 per incident with \$200,000 aggregate for the JPA.
